Whereas, Preliminary Notification no. 06/04/2021-3LGI/913 Dated: 07 June, 2022 was issued under section 11 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation & Resettlement Act, 2013" for acquisition of Land i.e., Property No. B-04-1837, for public purpose as it is creating hindrance in providing direct access to the Birth Place of Shaheed Sukhdev Thapar in light of Resolution No. 168, dated 31-12-2019 passed by the General House of Municipal Corporation, Ludhiana. This Notification was duly published in two daily newspaper "The Tribune" and in "Punjabi Tribune."

Whereas, Governor of Punjab is satisfied that the land specified below is needed by the Government for public purpose as it is creating hindrance in providing direct access to the Birth Place of Shaheed Sukhdev Thapar in light of Resolution No. 168, dated 31-12-2019 passed by the General House of Municipal Corporation, Ludhiana. In this connection, based on the census survey of affected families, a Rehabilitation and Resettlement scheme was prepared as per provisions of Section 16 of the said Act, by the Administrator-cum-Additional Deputy Commissioner (General), Ludhiana which was reviewed by the Collector Land Acquisition-cum-Sub Divisional Magistrate, Ludhiana (East) as per provisions of the section-17 of the act.

Whereas, Commissioner, Rehabilitation and Resettlement has approved the Rehabilitation and Resettlement scheme on dated 25.04.2023 and forwarded the said report to be made available to the Public and uploaded on the website of Punjab Government as per Section 18 of the said act. The summary of Rehabilitation and Resettlement scheme includes benefits such as choice of annuity at the lump sum rate of Rs. 5,00,000/- to each affected family, Resettlement Allowance of Rs. 50,000/-.

This declaration is made under the provisions of Section 19 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013."

And under the provisions of Section 21 of "The Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013" Public
